## Our Strategic Plan ...

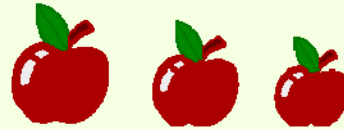

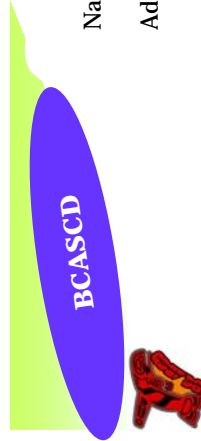
